ABOUT THE FUND

Who are we?

BanSenSuk e.V. is a German association aiming to support participation in community life for all by focusing on the promotion of vocational and academic education. **Stichting Ailine** is a Dutch Foundation focusing on solutions to the negative impacts of climate change on agriculture and natural resources and promoting awareness of the importance of sustainable (food) production. We cooperate in supporting small initiatives in educational and professional development in order to support the creation of a basis for generating income and participation in economic, technical, social and cultural developments.

Whom do we support?

We support **local groups** – especially in countries of the Global South - in their educational, community and employment or business development. We especially focus on initiatives that have less opportunities in the formal sector, both informal groups and community-based organisation or local NGOs (who do not have access to formal funding) and consider in particular environmentally friendly, socially inclusive (gender, ethnicity), replicable and locally embedded aspects.

As we know that starting up projects can be cumbersome in some aspects, we believe in the benefits of coaching. Therefore, we expect that your group will have a mentor or coach to advise on the project management and implementation. These mentors or coaches could be students or staff from universities, education centres or other trainers/coaches from institutes or NGOs, that are interested to support your project.

What do we support?

Local initiatives in the field of environmental protection/awareness, sustainable food production, agroecology, climate change adaptation and mitigation, education and employment approaches

How do we support?

We provide small funds up to 3,000 € per request.

How to apply?

The application should follow the **proposal outline** below and shall include information on motivation, objective, activities, timeframe, risks and risk mitigation, sustainability and finances.

When to apply?

Applications can be submitted all year round but must reach us at least **eight weeks before the start** of the project.

How is the decision made?

Our decision is made based on an **appraisal checklist**, considering feasibility, appropriateness, relevance, sustainability as well as inclusive, environmental and legal criteria. Applicants will be informed on the decision within four weeks. A corresponding contract will be issued for positive decisions. A liaising person or coach supports implementation and reporting.
